The township plans to retain this millage rate; Estimated expenses at \$251,790.00 which includes a 5% Contingency of \$11,990.00. This is a balanced budget due to our 3/31/18 carryover General Fund balance of \$271,539.00.

Neumann briefed on the FY 2019-20 Liquor Fund Budget: Estimated income at \$900.00 and Estimated expenses at \$913.00; This is a balanced budget due to the 3/31/18 carryover Liquor Fund balance of \$561.00.
