**Assessing** – Neumann reported that the Assessor will conduct her State Tax Commission recommended 20% Annual Review at KP Lake and Shupac Lake in 2020.

Liquor Inspector- Infante-Inman reported received and on file.

# **COMMISSIONS AND BOARDS:**

**Board of Review** – BOR met yesterday at the Township Hall to correct qualified errors, omissions, poverty exemptions, and mutual mistakes of fact; Neumann reported that they heard two cases.

Historical Society - No report.

Lovells Media and Reading Center - No report.

Lovells Township Planning Commission – Inman reported that they met last month to hear an application for a Special Use Permit for a "Home Occupation" on Lovells Road; The Commission unanimously agreed that the "Use" was a "Home Occupation"; The PC tabled decision on the permit until their January meeting in order to do research on environmental concerns addressed in the Public Hearing.

**Crawford County Planning Commission –** Inman reported that their December meeting was cancelled.

Zoning Board of Appeals – Neumann reported that they have no appeals pending.

### **UNFINISHED BUSINESS:**

 Neumann/Lovell briefed that due to potential loss of our PILT funding, discussions on possible selective hourly wage increases are tabled until the MI budget impasse is resolved; Board to consider at our February Budget meeting.

- 1. Neumann/Infante-Inman briefed on need to hire a new CPA as James Camiller has decided to terminate doing Township Audits; Board agreed to seek at least three proposals from CPA firms/individuals; Neumann to author "Request for Proposal".
- 2. Neumann briefed on Landfill Special Assessment District (SAD); Board will decision the SAD renewal after the required Public Hearing at our 1/14/20 Board Meeting; Board agreed to a 15-year renewal.
- 3. Board discussed Warbler's Hideaway Trash Disposal; Infante-Inman suggested increasing the Landfill SAD on our businesses that do not have a dumpster and not singling out Warblers; Lovell suggested adding SAD increase to our campgrounds only; Neumann to discuss with our Assessor; Tabled until our January meeting.
- 4. Hopp and Infante-Inman to attend MTA class on "Authorities and Responsibilities of Michigan Government" on 1/22/20 in Gaylord.
- Neumann moved, Lovell supported a motion to allocate an estimated \$646.00 for Board of Review members to attend their required annual training to be held 2/4/20 in Gaylord. All Ayes. MOTION CARRIED.
- Neumann briefed on Poverty Exemption Resolution; Neumann moved, Hopp supported a motion to adopt Resolution #12-11-2019 as presented; All Ayes. RESOLUTION ADOPTED.
