Regular Meeting of the Lovells Township Board

January 14, 2020

Supervisor Neumann called the Board Meeting to order at 10:00 AM. Followed by the Pledge of Allegiance.

10:02 AM-Neumann moved, Lovell supported a motion to recess the Regular Meeting of the Board in order to hold a Community Meeting regarding the river access site at the Co. Rd. 612 Bridge in Lovells. All Ayes. MOTION CARRIED.

Neumann briefed on the handout provided. 81 percent of the taxpayers who responded to our survey were in favor of the access site. Board answered questions on: Transporter System, Site Plan, Other Access Sites on the North Branch, Approval Process, Environmental Impact, downstream/increased usage concerns and Liability Insurance. Neumann made PowerPoint Presentation as delivered during the Grant Application Process. Board answered questions on: Quality of Fishing, Neal Godby MDNR stated that this is an improvement on an existing use, not a new use and that the three levels of permitting required would address environmental impact issues and Board would address any red flags as they appear.

11:25 AM-Board ended Community Meeting, Board thanked community for attending and a short break was taken. Most residents left.

11:38 AM-Neumann moved, Infante-Inman supported a motion to return to the recessed Regular Meeting of the Board. All Ayes. MOTION CARRIED.

Neumann requested Board permission to add two new business items to the Agenda. Board agreed.

Neumann moved, Hopp supported a motion to accept the minutes of the December 10, 2019 Regular Meeting of the Board as presented. All Ayes. MOTION CARRIED.

Neumann moved, Lovell supported a motion to approve pre-paid vouchers dated December 11, 2019 through January 9, 2020 as presented: General Fund totaling \$12,519.46; Direct Deposit Checks totaling \$5,185.14; Fire Fund totaling \$4,381.31; Landfill Fund totaling \$3,747.90, and Liquor Fund totaling \$9.88. In a roll call vote: All Ayes. MOTION CARRIED.

Assessing – Neumann reported that the Board of Review will attend Training in Gaylord on 2/4/20; They will conduct their Organizational Meeting on 3/3/20 at 3 PM in the Township Hall, Will meet with taxpayers in the Hall from 3 PM-9 PM on Wed., 3/11/20 and from 9 AM-3 PM on Thurs., 3/12/20.

Fire Department – Infante-Inman briefed on Chief Lewicki's written report; Total of seven runs in December (two Fire/five EMS); Total 2019: 73 runs (21 fire/52 EMS); Will be meeting with CSI tomorrow for the outfitting of a Suburban; Also, will be meeting with Feeny Ford in Grayling to get pricing on an Expedition.

Cemetery Sexton- No report.

Liquor Inspector- Infante-Inman reported received and on file.

Zoning Administrator – No written report; However, Neumann briefed Board on Clerk's email to Dale Gauthier, Jr. regarding the food truck use at Caid's Country Store; Dale responded that the use is a permitted use, therefore, a Special Use Permit is not necessary.

Zoning Enforcement Officer – Neumann reported-no open cases.

Board of Review - As reported under Assessing Dept.

Historical Society – Lovell reported that they met yesterday and are working on their new display; Beaver, Beer, and Banjo has changed their venue from the Tavern to the Township Grounds, Requesting snowplowing of pathway to the Museums in case of fire; Infante-Inman to follow-up with Mullins regarding snowplowing.

Lovells Media and Reading Center – Hopp reported, receiving book donations regularly; Copies already on the shelves will be sold at annual Bridge Walk; All is well.

Lovells Township Planning Commission – Denny Inman reported that they conducted their Organizational Meeting last night; Officers remain the same for another year; Set dates for 2020 meetings; The Special Use Permit Application tabled last month for a Home Occupation use of Auto Repairs was approved with conditions.

- 4. Neumann moved, Hopp supported a motion decreasing the reimbursable Township Mileage from .58 cents/mile to .57.5 cents/mile effective 1/1/20 as per the IRS standard which we follow as policy. All Ayes. MOTION CARRIED.
