Lovells Bridge Access Site

UPDATE !

Late last year we were notified that our MI Natural Resources Trust Fund grant application was approved. This approval will, when combined with cash and in-kind donations, fully support the construction of an access site on the state owned/township leased land at the County Road 612 bridge over the North Branch of the Au Sable. There has not been, nor will there be, any expenditure of taxpayer funds for this project. The engineering firm C2AE of Gaylord has been retained and preliminary site plans are being developed. Initial projections were for work to commence late this summer or early this fall. However, the COVID-19 pandemic may delay construction into 2021. The access site will consist of a parking area for standard vehicles plus an area for vehicles with trailers. The parking area will be connected to the river via a 160 foot long pathway that runs parallel to County Road 612.

Registration Deadlines

July 20, 2020-Last day to register in any manner other than in-person with the local clerk for the August primary election.
 July 21 thru 8 PM, August 4, 2020-In-person registration with local clerk with proof of residency.
 October 19, 2020-Last day to register in any manner other than in-person with the local clerk for the November general election.
 October 20 thru 8 PM November 3, 2020-In-person registration with local clerk with proof of residency.



Absent Voter Ballots

For the State Primary Election:

By 5 PM, July 31, 2020-Electors may obtain an absent voter ballot via First Class mail.

Up to 4 PM, August 3, 2020-Electors may obtain an absent voter ballot in person in the clerk’s office.

Up to 8 PM, August 4, 2020-Election Day registrants may obtain and vote an absent voter ballot in person in the clerk’s office or vote in person in the proper precinct.

For the State General Election:

By 5 PM, Oct. 30, 2020-Electors may obtain an absent voter ballot via First Class mail.

Up to 4 PM Nov. 2, 2020-Electors may obtain an absent voter ballot in person in the clerk’s office.

Up to 8 PM, Nov. 3, 2020-Election Day registrants may obtain and vote an absent voter ballot in person in the clerk’s office or vote in person in the proper precinct.

Polls are open on election dates from 7 AM until 8 PM in the Lovells Township Hall.
