A few thoughts for the upcoming winter months....

- ⇒ Per Lovells Township
  Zoning Ordinance
  Section 3.09 paragraph
  A2, all recreational
  vehicles must be removed from
  unimproved property in Lovells
  Township from December Ist through
  March Ist.
- ⇒ Looking forward to spring, be aware that there is a natural vegetation strip that extends 75 feet from the ordinary high watermark along the watershed of the AuSable River, to include Big Creek. Also all our lakes in the township have a natural vegetation strip that extends 50 feet from the ordinary high watermark.
- ⇒ Please be aware that any bank alteration on any rivers, streams or lakes in Lovells township requires permits from EGLE before work is done.

## **Community Item of Interest!**

Great Lakes Energy would like to expand their new fiber network, Truestream, to our area. The first step has begun; engineering contractors have begun to examine our location, the next step will be budget consideration and finally approval by their Board of Directors. This begins the process which will eventually provide fast, reliable, and stable internet to our community with no data caps. ## Rental and Use of the Township Hall, Library, Playground and Pavilion

As many of you know, the hall, library, pavilion and play-ground are often busy places. While the hall and library are only open for business on Tuesdays, Wednesdays and Thursdays, it is very common to have activities going on in the hall, playground or pavilion the other days of the week.

These activities could be hosted by local groups, such as Loose activities Could be nosted by local gloups, such as Loose Threads, Cheerful Givers or the North Branch Area Foundation and they pay no usage fee. Other activities, particularly when they are hosted by a family or an individual for a private function, would require the payment of a rental fee.

The township board recently received two complaints from groups that were using the pavilion. One complaints from paid a usage fee while the other had not. Both groups indicated to the board that their activity had been interrupted by children (under the age of 12 in these cases) who appeared at the pavilion without being invited and who were reluctant to leave when asked to do so.

The intent of this note is to alert all residents of this issue in the hope that, by being aware of the issue, it will cease to be one. In the near future signage will be made available to users of the hall and pavilion that will clearly convey that the activity that is occurring is private in nature. We are hopeful that the addition of this signage will have the desired effect.

In closing, the board would like to encourage the use of the Douglas Park playground. The playground is designed for children age 2-12, and it is open during daylight hours seven days a week. As we do for children visiting the library, we ask for adult supervision of all children at the playground who are under the age of 12.
